From the Occupy protests to the Black Lives Matter movement and school strikes for climate action, the twenty-first century has been rife with activism. Although very different from one another, each of these movements has created alliances across borders, with activists stressing that their concerns are not confined to individual nation states. In this book, Daniel Laqua shows that global efforts of this kind are not a recent phenomenon, and that as long as there have been borders, activists have sought to cross them. *Activism Across Borders since 1870* explores how individuals, groups and organisations have fostered bonds in their quest for political and social

change, and considers the impact of national and ideological boundaries on their efforts. Focusing on Europe but with a global outlook, the book acknowledges the importance of imperial and postcolonial settings for groups and individuals that expressed far-reaching ambitions. From feminism and socialism to anti-war campaigns and green politics, this book approaches transnational activism with an emphasis on four features: connectedness, ambivalence, transience and marginality. In doing so, it demonstrates the intertwined nature of different movements, problematizes transnational action, discusses the temporary nature of some alliances, and shows how transnationalism has been used by those marginalized at the national level. With a broad chronological perspective and thematic chapters, it provides historical context, clarifies terms and concepts, and offers an alternative history of modern Europe through the lens of

activists, movements and campaigns.

Anglo-Jewish organizations achieved remarkable successes in the pre-war years, combining their administrative expertise with the financial guarantee of maintenance to accomplish the rescue of over fifty thousand refugees. By tragic contrast, their lack of political and diplomatic experience during wartime rendered them almost entirely incapable of influencing an intransigent government engaged in global war to save Jewish lives.  
Jews and Jewishness in British Children's Literature - Madelyn Travis 2013-09-02

In a period of ongoing debate about faith, identity, migration and culture, this timely study explores the often politicised nature of

constructions of one of Britain's longest standing minority communities. Representations in children's literature influenced by the impact of the Enlightenment, the Empire, the Holocaust and 9/11 reveal an ongoing concern with establishing, maintaining or problematising the boundaries between Jews and Gentiles. Chapters on gender, refugees, multiculturalism and historical fiction argue that literature for young people demonstrates that the position of Jews in Britain has been ambivalent, and that this ambivalence has persisted to a surprising degree in view of the dramatic socio-cultural changes that have taken place over two centuries. Wide-ranging in scope and interdisciplinary in approach, *Jews and Jewishness in British Children's Literature* discusses over one hundred texts ranging from picture books to young adult fiction and realism to fantasy. Madelyn Travis examines rare eighteenth- and nineteenth-century material plus works by authors including Maria Edgeworth, E. Nesbit, Rudyard Kipling, Richmal Crompton, Lynne Reid Banks, Michael Rosen and others. The study also draws on Travis's previously unpublished interviews with authors including Adele Geras, Eva Ibbotson, Ann Jungman and Judith Kerr.

Cities of Refuge - Lori Gemeiner Bihler 2018-03-14

Contrasts the experiences of German Jewish refugees from the Holocaust who fled to London and New York City. In the years following Hitler's rise to power, German Jews faced increasingly restrictive antisemitic laws, and many responded by fleeing to more tolerant countries. *Cities of Refuge* compares the experiences of Jewish refugees who immigrated to

London and New York City by analyzing letters, diaries, newspapers, organizational documents, and oral histories. Lori Gemeiner Bihler examines institutions, neighborhoods, employment, language use, name changes, dress, family dynamics, and domestic life in these two cities to determine why immigrants in London adopted local customs more quickly than those in New York City, yet identified less as British than their counterparts in the United States did as American. By highlighting a disparity between integration and identity formation, Bihler challenges traditional theories of assimilation and provides a new framework for the study of refugees and migration. Lori Gemeiner Bihler is Assistant Professor of History at Framingham State University.

Dorothy Buxton led a remarkable life. In an era when women struggled to make their voices heard in the public arena, she spoke out effectively for the refugee, the destitute and particularly for children. An advocate of honest reporting during the First World War, in the aftermath she refused to accept the widespread famine that followed. In the face of scepticism and hostility, she campaigned to provide food for starving children in post-1918 Europe and pioneered the charity Save the Children. Her efforts saved thousands of lives. In later years, she was one of the first to raise awareness of anti-Semitism in Nazi Germany, courageously confronting Herman Goring himself in Berlin in early 1935. She was tireless in her fight

for those suffering from prejudice and discrimination. Her story is unusual, from her unconventional upbringing in rural Shropshire, to studying at Cambridge to emerging as an indefatigable campaigner. Dorothy was a complex and compelling character, somewhat of an enigma even to her family. Campaigning for Life is the first biography of this remarkable woman, which examines both her public and private life in detail, and crucially acknowledges her considerable achievements in one of the most turbulent periods of European history.

The welcome given to refugees from fascist Europe is part of our fond nostalgia for Britain's role in the Second World War, nestling in our imagination next to images of evacuees clutching teddy bears, and milkmen picking their way through bomb rubble during the Blitz. But there is a darker side to this story. Then, as now, there was great suspicion, resentment and fear towards new arrivals, much of it kindled by the tabloid press. Then, as now, politicians dealt with a reluctance to accommodate refugees by hiding behind bureaucratic hurdles and obfuscation. Many of the 10,000 Kindertransport children who arrived here in the late 1930s have warm memories of the kindness they were shown, but half a million refugees were refused entry and most of them died as a result. And those who were accepted found their troubles far from over. While Britain fearfully awaited invasion in 1940, 30,000 Jews were interned as 'enemy aliens' and some were sent off to the colonies on dangerous and sometimes fatal voyages. Nor were Jews the only refugees clamouring for the thin

gruel of public sympathy. Those fleeing fascism and civil war elsewhere in Europe found that whether they were met with kindness or hostility depended on the locals' political affiliations and newspapers of choice. Interweaving personal testimonies with historical sources, Paul Dowswell casts a fresh eye on the wartime era, painting a vivid picture of what life was really like for Britain's refugees.

Between December 1938 and September 1939, nearly ten thousand refugee children from Central Europe, mostly Jewish, found refuge from Nazism in Great Britain. This was known as the Kindertransport movement, in which the children entered as "transmigrants," planning to return to Europe once the Nazis lost power. In practice, most of the kinder, as they called themselves, remained in Britain, eventually becoming citizens. This book charts the history of the Kindertransport movement, focusing on the dynamics that developed between the British government, the child refugee organizations, the Jewish community in Great Britain, the general British population, and the refugee children. After an analysis of the decision to allow the children entry and the machinery of rescue established to facilitate its implementation, the book follows the young refugees from their European homes to their resettlement in Britain either with foster families or in refugee hostels. Evacuated from the cities with hundreds of thousands of British children, they soon found themselves

in the countryside with new foster families, who often had no idea how to deal with refugee children barely able to understand English. Members of particular refugee children's groups receive special attention: participants in the Youth Aliyah movement, who immigrated to the United States during the war to reunite with their families; those designated as "Friendly Enemy Aliens" at the war's outbreak, who were later deported to Australia and Canada; and Orthodox refugee children, who faced unique challenges attempting to maintain religious observance when placed with Gentile foster families who at times even attempted to convert them. Based on archival sources and follow-up interviews with refugee children both forty and seventy years after their flight to Britain, this book gives a unique perspective into the political, bureaucratic, and human aspects of the Kindertransport scheme prior to and during World War II.

**Living the Great Illusion** - Martin Ceadel 2009-07-16

Sir Norman Angell, pioneer both of international relations as a distinct discipline and of the theory of globalization, winner of the Nobel Peace Prize, and one of the twentieth century's leading internationalist campaigners on both sides of the Atlantic, lived the great illusion in three senses. First, his 'life job', as he came to call it, was founded upon and defined by *The Great Illusion*, a best-seller whose original version appeared in 1909: it perceptively showed how economic interdependence would prevent great powers profiting from war; yet it made other, less felicitous, claims from whose implications he spent decades trying to extricate himself. Second, his magnum opus and all his best work derived, to an extent unusual for a public intellectual, not from abstract thinking but from an eventful and varied life as a jobbing journalist in four countries, a cowboy, land-speculator, and gold-pro prospector in California, production manager of the continental edition of the Daily Mail, author, lecturer, pig farmer, Labour MP, entrepreneur, and campaigner for collective security. Third, he fostered many an enduring illusion about himself by at various times giving wrongly his age, name, nationality, marital status, key career dates, and core beliefs. By dint of careful detective work, this first biography of Angell reveals the truth about a remarkable life that has hitherto been much misrepresented and misinterpreted.
